VOTING

WHBC Constitution, Article VI, Section 7

Only those members on the **active** membership roll who are at least 18 years of age shall be entitled to vote.

WHBC Constitution, Article IV, Section 3

Voting shall be by ballot, and a three quarter majority of members **present** shall be required for election.

MEMBERSHIP - *WHBC Constitution, Article III, Section 1*

Any person professing faith in Jesus Christ as personal Savior and Lord, giving evidence of regeneration, and subscribing to the Articles of Faith and Church Covenant may present themselves as candidates to the Board of Deacons. Candidates may become eligible for membership in the church by giving public testimony of their faith in Jesus Christ and: 1) by believers baptism (immersion), 2) by Christian experience (having been previously baptized by immersion). The Deacons, having satisfied themselves that the candidate is eligible for church membership, shall recommend the same to the church. The church at any regular meeting shall accept or reject such recommendation by a majority vote of the members present.
